Eligibility: Sanctioned by USJI as a tournament **OPEN** to all current members of the USJI, USJA or USJF. Membership must be presented at time of registration, or membership in USJI may be acquired at registration.

Set Up & Rules: 1 mat will be used; Current IJF Rules & Sporting code will be in effect with USJI-standard modifications concerning Shime-waza & Kansetsu-waza for juniors & medical procedures. U.S. National rules will be in effect for situations not covered by the IJF rules (i.e.: Vacating uncontested divisions, etc.) Seniors = 5-minute matches; Juniors & Masters (3-minute

Awards: Olympic style gold, silver & bronze medals for 1st, 2nd & 3rd place, respectively, will be awarded in each division.
